The Board of Washington County Commission met in regular session on Monday, March 13, 2023, in the commission room at the Washington County Courthouse. Members present were Scott Zabokrtsky, 1st District Commissioner, David Willbrant, 2nd District Commissioner absent, and Raleigh Ordoyne, 3rd District Commissioner, Diana L Svanda, County Clerk to recorded minutes, and Cynthia Scheer, WCN

Scott called the meeting to order at 8:15 AM followed by the Pledge of Allegiance.

Raleigh talked about how the ambulance should be funded either by levy or sales tax or both. Diana is to check into Resolution to move forward.

Theresa Herrs, Communications Director discuss the control burn permit, it will be going back to the way it was before, Dispatch will advise of a warning, if the person does not agree they will be advise to call there fire chief. Once a month there will be a Siren test, it will be the first Monday of the month at 10:00 AM, weather permitting to check sirens.
