Members present were Scott Zabokrtsky, 1st District Commissioner, David Willbrant, 2nd District Commissioner, and Raleigh Ordoyne, 3rd District Commissioner, Diana L Svanda, County Clerk to recorded minutes, and Cynthia Scheer, WCN

David called the meeting to order at 8:15 AM followed by the Pledge of Allegiance.

At 8:15 AM Diana Svanda, County Clerk sworn in Chase Brazzle as the new Register of Deeds.

Scott Zabokrtsky made the motion to approve the consent agenda, Raleigh Ordoyne seconded the motion, all in favor, motion passed.

James Yungeberg, Environmental Science director submitted Chemical bids, Sims Fertilizers, VanDiest Supply company, Nutrien Solutions were all awarded different parts of the bids. James also reported that they had a broken part of their dozer, and he reached out to Foiley it will cost \$4500 to fix, Raleigh asked him to reach out to local welders to see if they can fix it. David asked James to look at Quivira Road to 3rd thru 7th he asked that it be sprayed., James told the commissioners there was an accident with their red trailer, he did not think it was worth fixing. Randy also submitted 5 questions from Keegan Bailey, North Central Regional Planning Commission 1. That the Washington county commissioners confirm a ARPA committee, 2. Confirm that David Willbrant will serve on the board, 3. The ARPA committee has the authority to determine how the funds are allocated., 4. ARPA will keep record of minutes., 5. Commissioners further confirm the County was approved and enter into contract with North Central Regional Planning Commission

on July 2021. Commissioners all agree with all 5 bullet points. Randy also provided information on a fire within the county. Commissioner had a phone conference with the ATT account Manager Shawn McFarland.
