

Commission Minutes November 13, 2023

The Board of Washington County Commission met in regular session on Monday, November 13, 2023, in the commission room at the Washington County Courthouse. Members present were Scott Zabokrtsky, 1st District Commissioner, David Willbrant, 2nd District Commissioner, and Raleigh Ordoyne, 3rd District Commissioner, Diana Svanda, County Clerk recorded minutes.

David called the meeting to order at 8:17 AM followed by the Pledge of Allegiance.

After returning to regular session Raleigh Ordoyne made the motion to go into executive session with Elizabeth under Land Acquisition for ten minutes to discuss contract review, Scott Zabokrtsky seconded the motion, all in favor motion carried. After returning to regular session Raleigh Ordoyne made the motion to let Washington County Hospital purchase Rachele Burrell House, Scott Zabokrtsky seconded the motion, all in favor, motion carried.

Commissioners asked Randy Hubbard to come and talk about on call time when you are called out for Ambulance, Fire, after discussion commissioners decided the policy says that you will be paid for the first two hours that you are gone, after that you will be required to take your PTO time.
