

## Commission Minutes October 30, 2023

The Board of Washington County Commission met in regular session on Monday, October 30, 2023, in the commission room at the Washington County Courthouse. Members present were Scott Zabokrtsky, 1<sup>st</sup> District Commissioner, David Willbrant, 2<sup>nd</sup> District Commissioner absent, and Raleigh Ordoyne, 3<sup>rd</sup> District Commissioner, Diana Svanda, County Clerk recorded minutes.

Raleigh called the meeting to order at 8:18 AM followed by the Pledge of Allegiance.

Tiffany Hayman, County Health Director reported that COVID shots are no longer paid for by the government and that it will be charge to insurance. They have seen 514 patients for flu shots. They are still doing Health Fair profiles, the profile is \$45.00, PSA is \$35.00, and Vitamin D is \$35.00, they are open Monday – Thursday 8:00 AM to 11:30 AM. To do health fair profiles.
