The Board of Washington County Commission met in regular session on Monday, July 8, in the commission room at the Washington County Courthouse. Jimmy has a meeting on August 1 with KDOT about a bridge in Hanover. On Heritage Road between 6 & 7 it will be closed Monday July 15 to replace pipe. Raleigh asked when they would start the road work in Linn, Jimmy thought July 15. David had budget questions. Denae joined the meeting, Jimmy asked about the refund of \$625,319 that they were to receive from TC energy, Denae said it was received July 28,2023 and it was put to cash and not his budget.

Tiffany Hayman, County Health reported the flooring is almost done. And they are starting up the back-to-school shots. Raleigh asked how things were going with the transportation, and asked if she has received any money yet, Tiffany told them no.

Tyler Garst, with Building Solutions, talked about facility upgrades.

Justin Cordry, Sheriff – Raleigh asked for an update on the squatters, also asked about the Jail and the income, Justin reported the Jail needs help.

Jimmy and Eric came back to do Tire bids, after review of one bid from OK Services David Willbrant made the motion to accept the bid from OK Services in the amount of \$15,238.00, Scott Zabokrtsky seconded the motion, all in favor, motion carried.

Ryan Kern, Economic Development/Tourism Director updated the commissions on the grant. Ryan is also working on a new logo for Washington County, Ryan presented different ones for approval.

Raleigh reported that Hailey Ordoyne had to step down from Pawnee Mental Health board, because of her new position.
